Primacy of Agreement. The party signing this document represents that he/she is the Customer or its authorized representative and has full authority to legally bind the Customer to the terms and conditions hereof. Customer represents that all purchases shall be for business purposes only and not for personal, family of household purposes.

CREDIT TERMS OF NET 30 DAYS FROM INVOICE DATE. Unless ITR America, LLC and Customer enter into a separate agreement for credit or unless ITR America, LLC agrees to extend credit for the particular purchase, in which case the terms and conditions of a separate credit agreement or the specific extension of credit shall govern. If ITR America, LLC and Customer have entered into a separate credit agreement, the provisions of that agreement are incorporated herein by reference, and Customer agrees to make payment within the terms set forth therein and on each invoice and each monthly billing statement. Customer agrees to pay all charges provided for by the credit agreement.
